

CAPITAL LIMOUSINE SERVICE

TERMS AND CONDITIONS:

The following terms and conditions apply to deliveries of transportation service from Capital Limousine Service, Denmark, CVR DK: 17231898, hereinafter referred to as Capital Limousine Service. These conditions apply in cases where there is no other written agreement between you as a customer and Capital Limousine Service.

Documentation and guidance: If there are proDect descriptions and manuals for the service, they will follow the delivery of the service from Capital Limousine Service. Capital Limousine Service warrants that the service meet the international requirements for services provided within travel and transport.

Delivery and transport: Delivery of service from Capital Limousine Service is considered done when the passenger is dropped off at an agreed, final destination.

Complaints: Complaints regarding possible mistakes on delivery from Capital Limousine Service must be claimed within a reasonable time after you have discovered the error. It is your Duty to describe and upon request, show the nature of the error. If you notice an error, please contact Capital Limousine Service without delay. Generally, you can only complain about defects that become apparent within the course of the service received.

Price and payment: If agreed, you can pay with the credit cards shown Dering the order submission. All prices are including Danish VAT, unless otherwise indicated. All export orders will be invoiced net of Danish VAT. Conditions of issuers of credit cards also apply.

Cancellations: Capital Limousine Service accepts cancellations according to Danish Consumer Protection laws. This means that you must contact us within 14 days before start of agreed service. If this deadline is not met a cancellation fee may be applied.
